Talking Books are available to customers with print disabilities. A print disability is a disability that prevents someone from reading conventional print, as defined in section 32 of the Canadian Copyright Act. See reverse for more information and eligibility criteria.

Talking Books are full-length audiobooks in multi-disc CD or single-disc DAISY formats. DAISY Talking Books can be listened to on a DAISY player that can change playback speed, bookmark pages, go directly to a specific page, and search within a book.

Talking Books customers can place holds and pick up the items at your local branch when available.

About Talking Books Status

Talking Books Status gives you access to the <u>Talking Books Collection</u> and exemption from:

- fines for holds not picked up
- being referred to a collection agency for long overdue items or charges.

Standard loan periods, borrowing limits, and suspension thresholds apply.

Please note you are responsible for:

- returning library materials
- receiving overdue notifications
- receiving billing notices for lost items
- renewing your card every year
- paying the replacement cost for lost or damaged materials
- informing the Library of any change to your print disability status.

Eligibility Criteria

A print disability is a learning, physical or visual disability that prevents someone from reading conventional print, as defined in section 32 of the Canadian Copyright Act:

- learning disability: an impairment relating to comprehension
- physical disability: the inability to hold or manipulate a book
- visual disability: severe or total impairment of sight or the inability to focus or move one's eyes.
